

### **Sales Terms and Conditions**

#### 1. Application

- 1.1 These terms and conditions apply to all sales made by VALOT s.r.o. unless specifically derogated from by other written agreement.
- 1.2 VALOT s.r.o. reserves the right to change these terms and conditions. The current terms and conditions can always be found on our website.

#### 2. Definitions

- 2.1 Customer: Any customer entering into an agreement with VALOT s.r.o. regarding the purchase of metal scrap.
- 2.2 **Products:** Metal scrap sold by VALOT s.r.o. to the Customer.
- 2.3 **Green List Contract:** Agreement compliant with EU regulations on the cross-border shipment of waste for recycling, ensuring materials on the green list are handled properly.
- 2.4 **Annex VII:** Document required under Article 18 of Regulation (EC) No. 1013/2006, which governs the shipment of waste within, into, and out of the European Union. This document is essential for the following types of waste shipments:
  - Green-listed recoverable waste (Annexes III, IIIA, and IIIB) exceeding 20 kg.
  - Waste destined for laboratory analysis under 25 kg.

### 3. Delivery of Metal Scrap

- 3.1 VALOT s.r.o. is responsible for ensuring that the metal scrap delivered complies with applicable legal requirements and agreed specifications.
- 3.2 VALOT s.r.o. must provide all necessary documentation for the delivered metal scrap, including any required commercial documents and Annex VII.
- 3.3 VALOT s.r.o. must ensure that the delivery complies with the Green List Contract requirements and provide necessary documentation.

## 4. Processing and Reuse

- 4.1 The Customer is responsible for processing and reusing the metal scrap in accordance with relevant environmental regulations.
- 4.2 To the extent possible, VALOT s.r.o. will assist the Customer in the reuse of devices and components if needed.

### 5. Payment

- 5.1 Payment terms will be agreed upon between VALOT s.r.o. and the Customer.
- 5.2 Any disputes regarding payment will be resolved in accordance with the agreed terms and conditions.
- 5.3 Payment terms can only be provided if there is an established credit line for the Customer, otherwise payment in advance will be required.

### 6. Quality and Claims



- 6.1 VALOT s.r.o. is responsible for ensuring that the metal scrap delivered complies with applicable legal requirements and agreed specifications.
- 6.2 Claims must be accepted by the Customer and reflected in the final price.
- 6.3 In the event of a dispute regarding a claim, a second test will be performed to verify the claim.

# 7. Changes to Terms and Conditions

- 7.1 VALOT s.r.o. reserves the right to change these terms and conditions at any time.
- 7.2 The Customer will be notified of any changes to the terms and conditions.

### 8. Governing Law

- 8.1 These terms and conditions are governed by the laws of Slovakia.
- 8.2 Any disputes arising from these terms and conditions will be resolved in the courts of Slovakia.
